

## **Summary of GTC Committee Meeting**

### **Minutes of previous meeting:**

### **Correspondence**

The Committee considered correspondence from N Barry who again expressed concerns about the arrangements for voting at the GTC AGM. Committee believed that assertions and information in Mr Barry's correspondence were not accurate and do not believe there any grounds to change the voting arrangements in place at the Club.

### **New Operator**

Committee noted a response from Tennis NT in relation to a draft agreement for Tennis NT to undertake the role of Service Provider for the Club. A meeting with TNT to finalise the agreement will be held shortly.

At the TNT Awards night, GTC was again awarded the Club of the Year for the third year in a row and the fourth time in the last five years, while Executive members, Ruth and Jamie O'Brien were awarded Club Persons of the Year and received the TNT Volunteer Achievement Award.

### **Treasurers Report:**

GTC is in a relatively good position. As of the 9th November 2020, Cash at Bank and Receivables is \$88,251.27, Accounts Payable is \$23,649.10, the Junior account is 7,791.15 and the Balance of the Transaction Accounts and Sinking Fund Account is \$56,811.02. Book-a-court has been a valuable investment for the club and led to an increasing trend in court hire.

### **Grants and Infrastructure**

Awaiting outcome of second round NTG Immediate Work Grant application for fencing replacement

### **Liquor license issues**

GTC have been granted a Community Club license but Committee believes a Club Authority or full license would be more appropriate. This will be a consideration for the new committee

### **Gardens Tennis AGM**

Arrangements for the 2020 AGM were discussed including communication to members of date, and required documentation, confirmation of eligible members, scrutineers and a nomination for Patron
