PRESIDENT'S REPORT

Welcome to the 2015/16 Annual General Meeting. I have pleasure in presenting this report on behalf of the Lindisfarne Memorial Tennis Club.

AROUND THE CLUB

In July 2015 the club purchased 2 wet weather court sweepers for use on the Plexicushion courts. These are stored in the silver shed on the river side of the club (accessed by your club key) and can be used by club members to sweep excess water from the blue courts.

The silver shed was purchased to provide additional storage space for the club in order to allow our club coach to use the brick shed next to the main clubhouse. In addition to the squeegees mentioned above, the club BBQ (which is available for members to use) is stored there.

The balance of the payment for the court resurfacing was made in January 2016. The club had retained 5% of the total payment as part of the contract as a warranty against the resurfacing. You may see cracks appearing on the surface around the Motor Yacht Club corner, which we believe to be caused by roots from the pine tree nearby. The Clarence City Council has consequently placed a root barrier between the tree and the courts in an attempt to reduce the impact of the roots. Our contractor has provided elastic cement and touch up paint which we will apply to the cracks in the warmer weather.

In February aluminium facia was added to the roof of the clubhouse to minimise the ongoing maintenance of the existing wooden facia boards. Thanks to Tony Rodgers for organising and overseeing this project.

As part of the ongoing exercise to bring the clubhouse interior to a more modern standard, new aluminium framed windows were fitted to the ladies and men's change rooms and also the main club room. With these fitted, the club can now proceed with the plastering of the ladies change room. The final stage of the renovations will be to lay new linoleum in the change rooms and the kitchen.

I give a vote of thanks to Dad's army who erected the shelter over two outdoor tables. This shelter came to the club via Dean Lamkin of LamCon, who removed it from Symmons Park as part of the enhancement and installation of a new stage in that precinct. A few extra bits were needed but basically we were able to reuse all the material supplied by Dean. Thank you, Dean.

EVENTS

The club entered two teams in the AYC competition this year and both teams came away carrying gold. The Division 6 team of Jean Woodward, Samantha Byrnes, Sean Hardman and Josh Lovell performed very well to win the grand final. Lisa McKay, Pip Morrison and Karen Garner, John McKay and Geoffrey Dunlop cleaned up in Division 7. Congratulations to all players involved.

In March the club hosted a Tennis Tasmania Junior event known as the Junior Development Series final Masters day, which was the culmination of a leadup series of junior events. Unfortunately it landed on Sunday of a long weekend when many of our volunteers were unavailable. Lisa McKay, Pip Morrison and Sam Byrnes stepped up to provide catering for the visiting players and parents, a monumental task for just 3 people. So a great big thank you to those three ladies for the mammoth job well done. The day raised around \$230 for the day.

Thanks to Lisa McKay for providing the music system.

For the first time in years Club Championships were played. Lisa McKay did a wonderful job in organising the championships and although the number of entries was disappointing, it all ran very smoothly. We will do better next year with a changed format. More on that next year. Narelle and Robert Miller of SRT Logistics were very generous with a \$1000 sponsorship of the championships which allowed the club to provide substantial prizes to the winners and runners up of the various events. James Anderson won both the Senior and Junior Men's events while Karen Garner won the Women's Senior and Rebecca Flinn won the Junior Women's events. Thanks to Narelle and Robert for their support.

The club purchased a Corporate Box at the Hobart International of which many members took advantage. Some great tennis well supported.

In the lead up to Christmas the club held a Children's Christmas Party for the first time in a long while. Lots of children and parents attended - the balloon lady was a winner.

The club held two Open Days during the year, the first was a great success, thanks to John Playle for the superb effort he put in to running activities for those who attended. The second was a flop, mainly because it was held on the Sunday of a long weekend. These activities are important for the club to promote itself and to be part of the tennis community.

Twice during the year the club hosted a 35+ social day for players 35 years and over, many coming from other clubs. We entertained them with tennis, food and drinks, and they went home very satisfied.

FUND RAISING

Thanks to one of our sponsors, Steve's Liquor, we were able to raise approximately \$1500 through the sale of cartons of wine. This was a very successful campaign and hopefully we can do it again next year.

Grant Fagan continued to run a very profitable activity through the sale of the Entertainment Books. This raises around \$500 for the club, well done Grant.

We now have more that fourteen local sponsors who support the club. As mentioned previously, the generous support of SRT Logistics is much appreciated as our major sponsor. The additional sponsors either through cash or kind add great value to our club, allowing us to provide a warm and friendly atmosphere to the club.

A Table Tennis table was purchased at the request of junior members' parents to offer some alternative entertainment when their coaching sessions are washed out or they are waiting for their sessions to begin.
