#### TREASURER'S REPORT:

Donald Smith and Rick Odgers presented the Profit and Loss Statement for 2020-21. The club made a profit of \$34,197.43 for the year. The club has a Court Sinking Funding bank account in line with requirements of the lease with Monash Council.

As of June 30, 2021 the club's bank balances were:

• Working account \$78,286.66

• Sinking Fund account \$11,083.62

### **SECRETARY'S REPORT**

Peter Splatt presented the Secretary's report to the meeting.

The year was again interrupted by the Coronavirus with the club being closed for a number of weeks on separate occasions and then initially restricted to singles play when reopened.

When the club reopened in late 2020 it received strong interest from new players. The club offered an extended membership to these players through to June 30, 2022. As a result, our membership grew towards 400 members and the income for membership more than doubled to \$25,000.00.

Due to the number of lockdowns the club had experienced and our strong financial position the club was able to offer existing members free membership for the 2021-22 year.

The new pavilion was finally completed and we were able to gain access in May 2021.

The club had a number of social groups during the day, but not at night. A Wednesday social night was started in February with about 25 people playing at various times. Each night 10–12 players were generally in attendance. A social group has also been established on Saturday afternoon and this is also growing.

Again, I must thank Donald Smith for his commitment and energies in his role as president of the club.

### **GENERAL BUSINESS**

It was proposed that there be no change to the club's membership fees for 2022-23.

Discussion was held on the casual court hire to non-members of the club. A motion was raised to increase court hire for non-members to \$20.00 per hour and light cost to remain at \$10.00 per hour.

Chris Ward questioned if you are able to book courts for only 30 minutes. The secretary was to check the ClubSpark settings.

Janne Humphreys discussed the cleaning of the pavilion and toilets which we share with cricket and soccer clubs. The club will need to address this with the other clubs.

Discussion was held about the area outside the pavilion and the groups that gather. Monash Council is responsible for this area. The council has very strict guidelines for installation of CCTV.

Vikki Mount told the meeting of the People's Choice Community Lottery. All proceeds are returned to the clubs nominated when the lottery closes. The club has made a group registration and \$360.00 has been raised so far.

Vikki discussed the need to improve club contacts with specific emails addresses for President, Treasurer and Secretary.

Vikki also spoke of the need to improve signage for the club. Mark Hao raised the need to improve signage of the courts.

Robert Humphreys discussed the need to target positions of responsibility for committee members and others. The workload needs to be spread over more people.

# **Life Membership**

Donald Smith was presented with Life Membership of Oakleigh Tennis Club.

Donald has been President of the club since 2012 and has overseen a number of changes in that time. In 2014, he was able to organise the installation of lights for the courts at the old Park Road site.

Two important events happened in 2017, with the proposed relocation of Oakleigh Tennis Club to Caloola Reserve and the merging of North Oakleigh Tennis Club with Oakleigh Tennis Club.

Donald spent many hours on the new facility to ensure the tennis club achieved the best possible outcome which we enjoy today.

Due to the meeting being held on Zoom, Donald's wife Wendy presented him with a plaque from the club acknowledging his life membership.

# GH Oakleigh Tennis Club - President's Report 2021

2020-2021 has seen a number of significant developments for Oakleigh Tennis Club (OTC) and the committee has worked very hard, even though the amount of tennis that could be played has again been severely limited due to the COVID-19 pandemic. A summary of what has been going on at the club is as follows:

- The terms of the Lease for the 8 courts at Caloola Reserve (for 12 years with a 10-year extension) were agreed with Monash Council and the Lease has now been signed.
- The terms of the Licence for our use of the Caloola Reserve Pavilion (as our clubhouse) were agreed and the Licence has now been signed.
- Construction of the new Pavilion was completed and the Pavilion was opened in April 2021, although with COVID-19 restrictions, our use of it has been very limited.
- OTC is still working with Monash Council on a number of issues that affect the running of the facility, and to ensure that all of the features that were promised as part of the Caloola Reserve Tennis Facility are completed in the near future, such as:
  - Installing an extra rubbish bin and recycling bin at each end of the spectator areas.
  - Connecting the on-court speakers to the office controls.
  - Connecting the solar panels and batteries to the pavilion's power supply.
  - Installing the TV antenna.
  - Fixing the water leaks in the kitchen.
  - > Upgrading the gate locks to make (keyless) evacuation in an emergency easier and safer.
  - > Improving security, after a number of recent incidents (especially involving broken glass) took place.
  - Fairly provisioning electricity charges to the soccer and cricket clubs who run commercial fridges and coffee machines 24/7 in their kitchen.
- OTC's committee has continued to manage use of the courts in line with Federal, State and Local Government regulations, and advice from Tennis Victoria, to ensure that everyone who attends the courts does so in a COVIDsafe manner, and we can track participants if necessary.
- OTC has changed from the Visit-Safe QR check-in code that we were originally recommended to use by Tennis
  Victoria to the Services Victoria QR check-in code that is now in use across the state. We encourage all users to
  check in for every visit.
- OTC has done its best to support our coaches from the Victorian Tennis Academy (VTA) through the pandemic, as it is our firm belief that a good club-coach relationship is vital to the mutual success of OTC & VTA.
- OTC and VTA are currently finalising a formal Club-Coach Agreement, which we hope to sign shortly, to ensure the long-term success of both parties by continuing our excellent cooperative relationship.
- OTC's financial position continues to strengthen, with our bank balances currently totalling over \$94,000.
   The increase in funds for the 2020-21 financial year was over \$34,000, which was an excellent result during COVID-19 restrictions.
  - These funds must continue to grow, as from October 2022 onwards, OTC will be responsible for all court maintenance (which Monash Council is currently spending over \$10,000 per year on), and the ultimate replacement of the court surfaces in approximately 15 years, which will cost, on today's rates, over \$300,000.
- OTC's membership is also in a healthy state, with 418 current members, compared to 250 as reported at the last AGM.

- Social tennis continues to be a strong point of the club, with organised sessions on Monday, Wednesday, Friday & Sunday mornings, Saturday afternoons and Wednesday nights. Other organised sessions are encouraged, with permanent bookings lodged in Book-A-Court, and promotion on the Social Tennis pages of our website, so please advise us if you wish to organise a new social tennis group.
- After heavily disrupted 2020 and 2021 seasons, OTC has 10 teams playing in the recently-commenced WDTA 2021 22 Summer season and 1 night tennis team:
  - ✓ WDTA Saturday morning Juniors 3 teams✓ WDTA Sunday morning Juniors 3 teams
  - ✓ WDTA Saturday afternoon Seniors 4 teams
  - ✓ WDTA Tuesday night 1 team

Thanks to James & Tina from VTA for organising team entries and supervising the Juniors, and to Peter Splatt for organising team entries for the seniors. Good luck to all the teams!

• There has also been strong usage of OTC's courts by non-members, evidenced by the number of Book-A-Court (BAC) PAID transactions. This is separate to the Book-A-Court member bookings, which are free.

This is clear evidence that OTC is open to members and non-members of the community alike.

- OTC has continued to receive sponsorship support from:

However, we are always seeking new sponsors, so your suggestions would be welcomed.

- OTC has participated in Monash Council's Club Development Program, which is a series of 13 on-line meetings from October to March designed to help us in the areas of Governance, Finances, Planning & Volunteers.
- OTC has also participated in the CLUBMAP series of 15 webinars, which are designed to help sporting clubs run more effectively.
- OTC is currently participating in the People's Choice Community Lottery to help raise funds for our ongoing court maintenance requirements. So far, this has raised \$360 for the club. Thank you to Vikki Mount for organising this.
- With OTC taking over the maintenance of the court surfaces from Monash Council in October 2022, the committee has been investigating the best way to keep the courts well-maintained in the more efficient & cost-effective manner. We have a special group working on this project, and we look forward to future developments.
- While the courts are relatively maintenance-free (compared to our previous en-tout-cas courts that needed to be swept and watered after each set), all court users should do their best to keep the courts clear of rubbish and especially tree leaves, nuts, branches and berries, which do lots of damage to the courts. I encourage all members to spend 5 minutes every time they visit to help remove this material even if it is not on the court you have booked to play on. We have a great facility. Let's keep it that way!
- Our Head Coach, Tina Keown, was one of 3 finalists in the Coaching Excellence category of the 2021 Victorian Awards. This nomination was thoroughly deserved, and congratulations goes to the winner Aidan Fitzgerald from GIANT Tennis in Bendigo.
- However, congratulations go to Tina Keown, Rick Foley and the whole VTA team for winning the Most Outstanding Club or Centre category of the 2021 Victorian Awards for the VTA Fawkner Park Tennis Centre.
