

On 19th October 2020, the South Perth Lawn Tennis Club (SPLTC) Committee unanimously voted to adopt By-laws as listed.

1. POLICIES

a) **The SPLTC hereby adopts the following Tennis Australia Policies**

- Member Protection Policy (note: includes Child Safety)
- Anti-doping Policy
- Code of Behavior
- Extreme Weather Policy
- Disciplinary Policy
- Tennis Anti-corruption Policy
- Social Media Policy
- Privacy Policy
- Whistleblower Policy

b) **The SPLTC has developed other specific policy as follow:**

- Health Policy, Procedures & Guidelines

2. Categories of SPLTC membership

a) **Ordinary Members to include**

- i) Full Members – able to play any day that courts are available
- ii) Life Members – able to play any day that courts are available without payment of annual fee
- iii) Mid-week Members – able to play Monday to Friday provided courts are available and Sunday Social tennis.
- iv) Provisional Members – able to play as per their application category while their membership application is subject to approval.
- v) Flexi Members – able to play up to 3 times per season on any day of the week and hire courts with 50% discount.

b) **Associate Members to include**

- i) Junior members 0 – 16 years – able to play Monday to Sunday excluding Saturday's Adult Social Play.
- ii) Junior member's nominated parent or guardian – able to play only with their child/children.
- iii) Social members do not have playing rights.

3. Nomination Requirements

a) **Each nominee shall provide the following details:**

- name
- address
- phone number
- date of birth
- email address
- for juniors, parent/guardian name, address, phone number and email address

b) **Ordinary Membership Approval Process**

Once a nomination is received, at least three committee members including the Club Captain or Acting Club Captain are to assess the playing ability of the nominee and provide their recommendation to the next Committee Meeting. If the three committee members cannot agree, then the opinion of further committee members must be sought.

c) **Associate Membership Approval Process**

Recommendation to the next Committee Meeting

4. Code of Conduct

Members are to:

- a) show respectful conduct to others in and around the tennis club premises and when representing the SPLTC at other venues; and
- b) demonstrate proper court etiquette.

5. Court Hire and Usage

- A. All court hire and usage must be booked through Book a Court
- B. Payment must be made at the time of booking through Book a Court. This information is on the Club's website <http://southperthlhc.com.au>.
- C. Playing under lights
Members are required to pay \$5 per hour and any part thereof.
- D. Parents hitting up with Juniors
Parents may hit up with Juniors, but they too must pay \$5 per hour if they play under lights.

E. Members playing with non-Members

Members may hire a court to play with a non-member or immediate family.

F. How to book

Courts are booked via the Book-A-Court system – refer to link on the club website

G. Organised social and pennant play priority

Organised social and pennant play, and their choice of courts to be used, has precedence over any other bookings.
