Terms and Conditions of Membership

Membership must be current before use of the courts. Members who allow membership to lapse have to re-apply for membership and have to pay joining fee again.

Membership Fees are non-refundable and only entitle access to courts and not clubrooms

Court and lighting access

- As part of membership each member is entitled to court access via the
 - o 'Book a Court' system accessible by going to https://www.tennis.com.au/sunshineparktc/
 - o Initial access is via an email invite
 - Courts must be pre-booked prior to use
 - Bookings may be cancelled at the committees discretion pending club sanctioned events
- Courts 3-6 can be used at night under lights
 - o Booking and payment for this light usage is again via 'Book a court'
 - o Fees payable via a 'stripe' account each member will need to create
- Additional terms and conditions may be listed on the 'Book a court' system

Members may be accompanied by a non-member guest who must pay a \$5.00 fee per person each time they play. Sunshine Park members must collect this fee off their hitting partners and give to a committee member within 48 hours of play. Failure to do so will result in cancellation of membership.

Tennis runners must be worn on the court surface at all times. If you do not have approved footwear you will be asked to vacate the court area.

Appropriate tennis attire to be worn at all times. Refer to tennis Australia guidelines www.tennis.com.au

The entrance gate to the venue must be locked immediately after play.

Court access is subject to availability

Alcohol is not permitted to be drunk on the court areas at any time

No Smoking within 20 metres of courts or clubrooms

Coaching at Sunshine Park Tennis Club Inc to be only carried out by Club contracted coaches

A limit of 4 tennis balls to be used per court. Club contracted coaching exempt.

Courts 1-2 to be bagged after use. EN TAUT CAS courts to be lightly watered before play and at least every 30-40 minutes

All rubbish to be removed from court area after play

Sunshine Park Tennis Club Inc committee reserves the right to settle any disputes between members, casual players and the Club.

No play before 6.00am or after 10.00pm. Club sanctioned activities exempt.

Financial juniors and a parent and senior members are eligible to cast a vote at AGM or any designated club votes. Family memberships are limited to one full vote per listed family member.

No bikes or toys allowed inside court area at any time

No bad behavior, racquet abuse or foul language will be tolerated. You will be asked to leave the premises and the matter referred to Club committee for action

All members who play competition for Sunshine Park must adhere to clubs code of conduct and where club polo's during sanctioned competitions. Membership does not guarantee you will get into a team for competition. Club committee makes final decisions on teams.
