

# Tennis Tasmania and Taroona Tennis Club - Relationship

Except where permitted or required by law, or where your consent is obtained, this information will not be disclosed to third parties.

# Parental Responsibility for Children

The Club has a generous fee base for members' children who are encouraged to become part of tennis. However, the Club does not bear any responsibility for unsupervised children and trusts that parents will exercise appropriate judgement regarding supervision. Players under 18 cannot play at night-time under lights unless an adult member is present. Parents seeking to join only children under 10 (free) must take out a non-playing membership (\$50) which enables those parents to hit up with their child.
