We would like to inform you of a few changes we are trialling this year. Feedback from last year and challenges with finishing matches got us thinking.
This year we trial a "one-day one-venue" scheduling approach. Teams will play their 2 scheduled matches for the day at the same venue. Tennis balls and score sheets will be issued and returned at that venue. Results will be entered by Captains onto the (enhanced) App used last year. The App will also be used to inform you of team tallies after each round, and any division splits or play-offs should they be needed. The Score Sheets have a QR code for accessing the App (or you can type in a web address)
Sometimes in the past we combined nominated age groups to ensure 6-8 teams in a group. 8-team groups split into 2 divisions halfway through the weekend. This year we are adding " 4 team" groups in the mix.

We hope this will minimise the need to combine age groups, or move a team into a younger age group.
And in consideration of our older talent, we are including a 75+ age group.
As there are 4 venues (Berri, Barmera, Loxton, Renmark) teams will play at only 3. Catering is being arranged at venues by local tennis clubs. Presentations will be back at Berri later on Mon afternoon.
Egg \& Bacon breakfasts available at BERRI courts Sat, Sun \& Mon mornings. Saturday night you are invited to a get-together at Berri Courts with pizzas available from the adjacent Berri Riverside Holiday Park. More details, and other social activities to be promoted in later email bulletins to Captains and on our Facebook page (Riverland Teams Carnival).

## May $36{ }^{\text {th }}$ Riverland Teams Carnival <br> (May 18 ${ }^{\text {th }}, 19^{\text {th }}-20^{\text {th }} 2024$ ) <br> CONDITIONS

1. The conditions shall be open to all tennis Seniors players over the age of 30 years as at $31^{\text {st }}$ December 2024.
2. All entrants must be Members of the Tennis Seniors Association of South Australia or of an interstate Tennis Seniors Association. If not a \$25 Registration Fee for the weekend will apply.
3. The Tournament Committee shall have complete control of the competitions and may vary the conditions as required by the circumstances. Any Disputes shall be dealt with by the Tournament Disputes Committee whose decision shall be final.
4. The Tournament Committee reserves the right to combine age groups if insufficient entries are received.
5. UP TO SEVEN PLAYERS MAY PLAY IN EACH MATCH, BUT NO PLAYER CAN PLAY IN MORE THAN TWO SETS IN EACH MATCH AND NO player can play with the same player more than once in any one match.
6. If a player takes ill or is injured during play in any set and cannot continue, then that set must be forfeited to the opposing team. A nominated player from the same team may play in any subsequent set or sets of that PARTICULAR MATCH.
7. EACH MATCH Shall consist of four 9 game sets - tiebreaker at 8 all. Four pairings of each team to play one set against four pairings in the opposing team. All four pairings of each team to be written on score sheet prior to commencement of match. (An individual can play twice (once in pairing 1 or 2 AND once in pairing 3 or 4) but NOT TWICE WITHIN PAIRING $1 \& 2$, OR TWICE WITHIN PAIRING $3 \& 4$ ).
8. The winner of each match shall be decided by the number of sets won and, if sets are equal, then by the number of games won. Three points shall be awarded to the winning team and one point to the loser, plus point one for each set won. Two points plus point one for each set won, shall be awarded to both teams in the event of a dRAW.
