KEY RESPONSIBILITIES & DUTIES/TASKS of this Subcommittee:

Organisation and management of all weekly or other “non-tournament” competitions conducted by or on behalf of the Association, including but not limited to:

- organising match draws for **TSSA Summer & Winter Weekly Competitions**, using TA’s League Manager to develop the match draws
- appointing a Competition Coordinator/s for each Summer and Winter Competition organised by TSSA
- recording all TSSA competition results, using TA’s League Manager
- generating reports containing statistics of teams and players participating in TSSA Summer & Winter Competitions, and providing reports as required
- liaising with TA’s Support Team in resolving any TS League Manager system issues as they arise
- appointing a **Social Play Coordinator** for each **TSSA Social Play Session** held at the **Centre**

Organisation and management of regular/weekly Social Play & Open Court Sessions conducted by or on behalf of the Association.

Promotion of the following TSSA policies amongst TSSA members, and monitoring compliance:

- **TSSA's Tennis Etiquette & Rules for Non-Umpired Matches**
- **TSSA's Competition Rules**
- **Notes for TSSA Competition Coordinators & Team Captains**

Liaison with key stakeholders including:

- Tennis SA,
- AHC, and
- Consortium representatives

regarding scheduling and conducting of TSSA competitions, social play/open court sessions, tournaments & carnivals

Oversee the management processes and procedures for the purchase of new tennis balls and sale of used tennis balls.

Implement negotiated **TSSA Strategic Plan 2019-22** strategies/tasks relevant to this Subcommittee.
