COURT HIRE FEES *for* SOUTH PARK TENNIS CENTRE *

for 2020-21 TSSA Tennis Year (1st October 2020 to 30th September 2021)

ONE OFF USAGE *per court*

DAYTIME - **\$35 - 45/Court/one-off session** (3 - 5 HOURS DURATION *with start & finish times to be negotiated/determined*)

This charge has been calculated based upon:

- i) a court accommodates 4 players,
- ii) TSSA Member/Player is required to pay \$55 for maintenance and that equates to approximately \$3/player/session for a season
- iii) TSSA Member/Player is required to pay \$5/player/each session

NIGHT-TIME - **\$55 - 65/Court/one-off session** (3 - 5 HOURS DURATION *with start & finish times to be negotiated/determined*)

This charge has been calculated based upon:

- i) a court accommodates 4 players,
- ii) TSSA Member/Player is required to pay \$55 for maintenance and that equates to approximately \$3/player/session for a season
- iii) TSSA Member/Player is required to pay \$10/player/each session

Hirers will be charged a one-off fee for the period of time and numbers of courts that have been approved to be booked.

This fee would normally be expected to be paid upfront with the hirer standing the loss for any matches cancelled (*e.g. due to inclement weather and forfeits*) during the period for which the courts were hired.
