The **TSSA Tournaments/Carnivals Subcommittee** must act in accordance with any regulations formulated by the **TSSA Committee**

CONVENOR:

Karen AHRENS, TSSA Committee Member *with support from* **Michael POCOCK, TSSA Chairperson** *and* **Frank SPIEL, TSSA Secretary**

KEY RESPONSIBILITIES & DUTIES/TASKS:

Overall responsibility for the organisation and management of all tournaments/carnivals conducted by or on behalf of TSSA, including but not limited to the TSSA annual State Championships event.

Coordinate the establishment of, and support for task groups required to conduct TSSA tournaments/carnivals and those that TSSA explicitly support e.g. Annual Berri Teams Carnival. Provide progress reports to the TSSA Committee on the work of established task groups on a regular basis.

Establishment of a **Senior Tennis State Teams' Selection Task Group**, with responsibility to: -

- select players to represent TSSA in any tournament, competition, or carnival, including but not limited to-
 - annual Australian Teams Carnival
 - annual City v. Northern Areas Match
- allocating selected players to teams
- appointing team captains
- designating players' order-of-merit, if required
- recommending to the TSSA Committee any changes in the uniforms to be worn by those players selected to represent TSSA

The **Selection Task Group** must act in accordance with any regulations formulated by the **TSSA Committee**.

Liaison with key stakeholders including:

- Tennis SA
- TSA (as needed)
- AHC, and
- Consortium representatives

regarding the scheduling and management of tournaments/carnivals conducted by or on behalf of TSSA.

Develop **Guidelines for Conducting Annual TSSA State Championships Event** (*including Personnel Resources*)

Implement negotiated **TSSA Strategic Plan 2019-22** strategies/tasks relevant to this Subcommittee.

GLOSSARY:

AHC	Adelaide Hockey Club Inc.
AIC	Australian Individual Championships
Association	The Tennis Seniors Association of South Australia Inc.
Australian Teams Carnival - ATC	Held annually, usually in January and hosted by State organisations, generally on a rotational basis. The championships are normally held over two weeks, with the teams’ event in the first week and the individual championships in the second. Each year, the delegated host Division conducts the Championships in accordance with the TSA Regulations for the Australian Teams Carnival - Revised July 2017 (open hyperlink to read and note latest version) 2020 Australian Seniors Championships will be held in Busselton and Bunbury, WA.
Centre	Park 20 complex that consists of 18 tennis courts, clubhouse, carpark and surrounds at 118 Greenhill Rd, Adelaide.
City vs Northern Areas match.	Annual one day event, normally held in early Autumn (March) between City and Northern Areas representative teams playing for the Memorial Shield .
Consortium	South Parklands Hockey & Tennis Centre Inc, an incorporated body managing the lease and obligations of the Park 20 complex
Host State	A Tennis Seniors State, or other Organising Body, approved by TSA to host the ATC.
Park 20	The name applied by the Adelaide City Council to define the 18 tennis courts, clubhouse, carpark and surrounds at 118 Greenhill Rd, Adelaide.
State	Any affiliated member Association of Tennis Seniors Australia, which can also be defined as a State or Territory Association e.g. TSSA, or an overseas representation.
TA	Tennis Australia (the governing body for the sport of tennis in Australia).
Tennis SA	Tennis SA (the governing body for the sport of tennis in South Australia).
TSA	Tennis Seniors Australia Incorporated (aka ‘Tennis Seniors Australia’). TSSA (together with all other States’ senior tennis organisations) is currently affiliated with TSA.
TSSA	The Tennis Seniors Association of South Australia Inc.
