The letter was forwarded to Minister Steel. The Club has not received a response from Minister Gentleman or Minister Steel. Graeme will follow up directly with Minister Steel.

- 4.14 **Competition Flags:** Graeme is in the process of digitalising the competition flags which go back to 1975. He is also working on a league article.

- 4.16 **Tennis Ball Tubes:** The University of Canberra Research does not need to collect anymore tennis ball tubes for her experiment/research. Graeme may know of some other use for remaining empty ball tubes.

- 5.2 The Club received an email from Mrs Li requesting a copy of the Contract between the Club and Mark Walton's Canberra School of Tennis and in particular "exclusive contract" rights. The Club responded that it would not provide a copy of the contract as it was commercial in confidence. In relation to the "Exclusive Coaching rights", the Club advised that the Club Coach has exclusive rights to provide professional coaching services at the Club. The Club Committee is obliged to monitor for third party coaches or members who attempt to provide coaching for a fee, which is not allowed on its premises. One of the reasons for this restriction is the absence of public liability insurance in relation to unauthorised coaches. There is also the matter of ensuring external coaches are authorised under the ACT Government's "Working with Vulnerable People" requirements.

- 6.10 The Committee supports ACTSMART's energy saver initiatives where the ACT government will offer a rebate of 50%. This would cost the Club around \$2300. Geoff is still seeking quotes. **ACTION: Geoff to obtain quotes for ACTSMART energy saver initiatives.**

I would like to particularly thank Tim Harris for the work he has done to prepare and maintain the grounds, and also Lorraine Ovington for her tending of the gardens. Tim spends many hours looking after the surrounds and carrying out maintenance jobs as needed. His efforts are very much appreciated and his hard work is there for all our members to see and enjoy.

#### **Court Fencing**

Waiting for materials and some fine weather

#### Landscaping

The cotoneaster growth from the south and east fence lines may need revisiting soon.

#### **Solar Panels**

The "Smart Meter" has been installed. The first invoice, after a few hic-ups, showed a decent rebate.

#### **EFTPOS Machine**

Max has also done some research on this item.

A "Zeller" stand-alone system has been recommended, available at Office Works:

- Terminal \$299.00
- Charging dock \$39.00
- Terminal receipt rolls \$29.00 for 20 rolls
- 1.4% processing rate for each transaction
- Sim card monthly charge \$12.00 (needed because we have no internet at the club)

#### Many questions:

- Who will operate the system? Which payments (memberships, pennants, social)?
- Where will equipment be stored?

#### Equipment/material shed.

Our current shed has become the storage place for grounds maintenance equipment and materials, to the extent where entry has become dangerous.

It is suggested that another shed be constructed along side the existing – estimated cost \$650.00 to house equipment etc.

#### **Court Lighting**

The circuit breaker to Court 1 lights are still being tripped during wet weather and the southern light is not functioning at all. The contractor has been made aware and will fix the problems (or else).

### **ACTSMART Energy Efficiency**

Quotes are being sought for work items suggested by Actsmart which will save energy. A rebate of 50% will be granted by the Govt. for the completed items.

## **Coach Report**

Hi all, so the junior/coach report finally has some good news since our last report Finally since the dreaded 12<sup>th</sup> Aug when we entered lockdown, we have finally been able to recommence work with face to face contact & coaching with covid safety practices. We started 1:1 private lesson coaching & as restrictions slowly changed, we have been able to move forward with varied programs to the point where last week we were basically able to resume normal tennis coaching & activities again. No doubt this term will be quite compromised from a normal end of term tennis, but we still have many things to be thankful for.

Firstly I would like to thank the club for their support in working together with CSOT & how we navigated the restrictions as we became aware & also for their generous reduction in court usage fee's whilst we dealt with the pandemic.   week. It is a 5 week program at the school due to covid & perhaps we can promote WCTC &

  response as we speak. I have suggested we do an Open Day off the back of The Aussie Open,
  but this is TBA.
- Open Court Sessions we have signed up the club as part of the Summer of Tennis
  promotions with Tennis ACT to do an Open Court session on Fri 21<sup>st</sup> Jan in the twilight.
  Details are still vague, but some of the activities will be CSOT running tennis
  coaching/activities, social play, Big Screen TV outdoors with the Aust Open Tennis on view,

- food vans & more all to be done in the twilight into the evening. This will be a new style of Open Day to be done in conjunction with TA, Tennis ACT & the Aussie Open marketing.
- We have also signed up as play tennis Champions for the club. Again details are still vague, but it is part of a marketing plan from now till March thru Tennis ACT & TA, which will be done as a social media campaign.
- We probably need to look at making decisions on what Open days we will run around or just
  after the Aussie Open. As mentioned we have locked in the Open court sessions, however
  we may also want to look at a club Open Day just after The Aussie Open, when the kids are
  back at school as well. This is because Jan can be a transient time for Canberrans with a lot
  of people holidaying away from Canberra until school recommences.

I have recently completed a child safety course with Tennis Australia & this will help with Tony & myself as we plan & articulate our position to the WCTC community towards our Child Safety Plan.

I also did a disability course last week & am hoping to use contacts & ideas to further our vision tennis commitment & also female tennis & leaders at the club.

Finally as Peter has mentioned, Max, Tony, Carl & myself met before covid to discuss ideas about the Club & sponsorship packages. This probably can be tabled in general business, but we do believe we have huge potential in this area, we just need to be savvy in how we deliver these ideas.
