The Club will also get the electrician to do other electrical work (Canopy) as well while he is here. 3. It is proposed that the Gazebo's will be officially opened at the next Open Day, when the kids can attend, and after the school holidays / Australian Open. The Club would also invite ANZ to attend the opening as they sponsored the new Gazebo's. 4. ACTION: Hugh to procure new tables and chairs for new Gazebo's which are similar to the old ones by the start of the busy peak holiday period so they can be used during the summer season. **Club Security** 1. 

Book a Court Settings Change - Weston Creek Tennis Club

Hi Brian,

Thank you for chatting with me this afternoon.

As discussed, to get ready for the upcoming launch of the National Book a Court website, there will be some minor changes to your current Book a Court settings:

- You have opted to continue to charge guest fees for members bringing a guest. Members will still have the ability to add guests through your venue's existing landing page. However, if they book through the National Book a Court website, there is no ability to add a guest and therefore these guests won't be charged. We will drive members to your venue's landing page through a 'are you a member of this club?' button on the National Book a Court website.
- In addition, following our call, I have also noticed that you currently use the itemised costs feature. This feature will not be present on the new website, however, it will still be available for members on the current club landing page. As a result, on the new website, when a casual player makes a booking, they will see the total cost only, rather than a breakdown of the total cost. Members that book through the existing page, will continue to see both the court and lighting costs, as well as the total costs.

In addition, I will ensure that our team continues to complete membership updates regularly for your club, as well as sending invitations to new members.

The 'Hooker' charity tennis day - Feb 2019

Hi Geoff,

I spoke to Jason this afternoon re their proposed charity day at our Club in Feb 2019. The charities are regular Hooker ones, so there is not a problem there

For planning purposes, the plan is to use all 12 courts between 1000 -1600 hours on Sunday 10 February.

Geoff	 Reported on recent ACT Sports and Recreation Grant Application. Application was submitted on time but without a formal quotation. Court Craft had said they would provide a quote but failed to do so and haven't responded to further requests "after the event". Synthetic Court Group (Hayden Garn) provided an informal quote using "Laykold Master Gel". The quote arrived too
	 late for inclusion in the application. Active Energy (Don Bevan) advised that they were too busy to quote and would not commit to any more work till mid 2019. It appears obvious that the amount of money being "thrown around" at present will result in elevated prices and inferior end products as jobs are rushed or inexperienced operators are engaged to get projects finished in limited time frames
Chris	Spoke on the desire to have clubs become self-sustaining in future. A quick calculation showed that this would require WCTC to double the amount of money it puts into the accumulation fund for asset replacements.
Chris	Introduced "Bounce" – a collection of templates and guidelines to assist in club management.
Chris	Advised that our initial application for National Court Rebate (NCR) has been accepted and we should proceed to the next stage of the application process (See "Bounce") He also advised that because of the volume of application received we may only get \$50,000 instead of the \$104,000 applied for. This may cause problems with budget/scope of works.

Email from Dan Green on Plexicushion courts

Hi all,

The agenda reminded me of an action item I had from last meeting about court surfaces for which I had the following email in my drafts but hadn't sent.

I contacted TennisACT for further information re court surfaces and a list of Canberra surface types and contractors etc. I was hoping that they could present something to those present at the October 19 meeting and Geoff has informed me that they did provide some brochures. Otherwise I didn't hear anything further. I found the following information below which is useful:

I have also spoken to Victor Violante, the secretary of Forrest Tennis Club about their experience. As Clair forwarded earlier, they had issues with the surface having to be re-layed. Victor advised me that they used a company called Grassports

Australia https://www.grassports.com.au/ Victor said the company had a good track record with all kinds of sports surfaces, and they also did an artificial grass court for Forrest which has turned out well.

Victor was going to get back to me with the exact specifications of the surface but they did not go with Plexicushion. Instead they used a relatively untested acrylic surface on an existing concrete base with a rubbery under-surface over the concrete. They were told it is easier on the joints than regular hardcourt and the cushioning is supposed to last longer than with plexicushion, the former being a key selling point for their older membership base.

Unfortunately it wasn't laid properly and the surface has deteriorated substantially. It is covered under warranty and was due to be resurfaced in November. Victor said the company has been good to deal with, accepting full liability but obviously wouldn't be recommending this company/surface at this stage!
