- 6.5 Our application for the for \$12,000 to supply and install 30 solar panels through "Community Energy Efficiency and Solar Grant " has been successful.
- 6.6 Book a Court usage fees have increased by around \$1700 during the COVID-19 period which is good for the Club.
- 6.7 There was no land rate for 2020 as the ACT government has waived these rates due to COVID-19. The Club is in credit for rates of around \$1100 as it already paid the rates before the waiver was introduced due to COVID-19.
- 6.8 The ANZ bank account is the loan for the courts resurfacing. The Club will need to repay off around \$1430 per month over the next 5 years in order repay the loan. Payments currently made will cover the Club until the end of this financial year (in case of hardship).
- 6.9 The Club was successful in its solar panel grant of \$11,945. Tim found the hole in the roof and Geoff believes the roof is good enough to hold the solar panels and that is does not need replacement. However, Geoff has made an appointment with a roof plumber to have a look at the roof and give his opinion on its suitability to take solar panels, to quote on replacement if it is not and to quote on removal of superfluous vent pipes and patch the roof if it is. He has spoken to the contractor and again asked if there are likely to be any additional expenses, namely replacing the existing meter box and anything which may affect the existing distribution board. The contractor, same as lighting people, will be delivering a scissor lift, or similar, to site on Friday so that they can start work at around 6.00 am Monday to check the light angles. Geoff will organise to let them in on Friday and may have to unlock gates on Sunday to let them get started on Monday morning. The solar panels would provide electricity for the whole club and be fed into the power grid with the Club getting its bills subsidised. The solar panels and inverter would be totally subsidised by the government. The only possibly location for the inverter would be on the north wall of the club house.
- 6.10 There is still around \$2100 in the bank to pay for the fencing. The Club will wait until spring to tidy up the bottom of the fencing.
- 6.11 The Committee agreed to hire landscaping company Diggin It for around \$3700 to do some work on the Club's gardens outside the fences. This would include cutting the roots outside courts 9-10, mulching, dig out near court 5 where the water pools and dig up the corner and remove brier and make galley on the northern courts. Brian undertook similar root cutting to the courts last year (southern side of court 9 & 10, eastern side of court 9 and western side of court 12) but the roots have grown back. Graeme and Tim to consult with Brian beforehand on roots.

- 6.13 Overall membership numbers are quite strong. Generally, members were very good at renewing their membership at the start of the COVID-19 crisis when memberships were due. This has greatly assisted the Club's finances and Brian thanked its members for renewing so promptly.
- 6.14 There is still a major issue with the Book A Court system for when members bring a guest as they don't always collect money from non-members/guests. It would help if players were linked to the membership database. Apart from that, the Committee is not sure how this could be resolved in the system, without policing users like during the COVID-19 period in April-June 2020.

- 2. WCTC President Stewart Back attended **Tennis ACT President Meeting** on 10 August 2020. Kim from Tennis ACT attended and discussed the Sustainability & Investment in the ACT Community Tennis Clubs; Kim has incorporated the "Briefing paper to the TACT Board" into this document which will be re-circulated for further review and comment by the community. The second agenda item relating to COVID-19 requirements for club covered discussion on club liability and cleaning routines. The next meeting was agreed to be held at the Ainslie Tennis Club within the next three months. An action from the meeting, agreed to by Kim, is for Mike Rethman to visit the clubs to brief on grant opportunities, maintenance POC and facility maintenance issues common across the ACT clubs. It was also requested that the list of maintainers held by TACT is distributed amongst clubs.
- 3. First edition of the **Bean Business and Community Grants Bulletin** received by David Smith MP. This bulletin provides an overview of Australian Government, ACT Government, and philanthropic grants that are currently available to individuals, businesses, community groups and organisations. This includes a number of grants that are specifically aimed at assisting people get through the current COVID-19 pandemic. This bulletin will be distributed every 6 weeks. - 4. Tennis ACT released the final draft paper "Sustainability & Investment In ACT Community Tennis Clubs". The aim of this document is to outline the intended approach to the ACT Government with regard to the infrastructure situation facing tennis club facilities in the ACT. It is the outcome of the proactive approach taken by the Club Presidents to propose solutions to the financial challenges facing clubs with ageing and deteriorating assets.
- 5. Blake Dean was interested in installing some **cricket retractable nets** on the WCTC courts and renting long term for his cricket business. This was rejected by the WCTC committee due to concern of damaging the courts, using courts for other purposes and taking a court out of being used.
- 6. LJ Hooker is interested in booking the WCTC courts again in Feb 2021 for their **Tennis Charity Day**. No objection from Committee.
- 7. The Club has signed up to free membership with **Sports Community**.
- 8. All Canberra players are invited to play in the upcoming **Tennis ACT UTR event**! This event is open to all standards and offers level based play. Once players enter the event, they will be divided into unisex draws based on UTR. More information <u>HERE</u>.

Projects Report - Aug. 2020

Court Lighting

ACTEW had made an appointment to check the angles at which the court lights had ben set. This was to see whether, or not, adjustments could be made whereby the light intensity could be improved to specified levels. The appointment, for Friday 7 August, was abandoned due to weather and a new time will be made.

Court Fencing

The funds from the "Volunteers Grant" are to be used on :

- "First aid and Safety" meaning materials to control the base of the chain wire fence. and
- "Outdoor furniture and equipment" meaning paint and painting equipment used on the chain wire fencing.

Graeme has done a fantastic job in painting the fence poles. We may need to organise work parties to do the work involved with the base of the fencing.

Landscaping

Tim and Graeme are continuing to make improvements to the grounds, the old swing frame will be demolished soon, the timber will be used for retaining earth around the main water control area near the back gate.

"Community Efficiency and Solar Grant

The grant was successful, although we have until 5 September to Accept it. This depends on "THE ROOF". Graeme feels he has found the main cause of the roof leakage and we will look at that firstly rather than contemplate new roofs etc. The following may be irrelevant, (not Lorraine's Locker)

Club house Roof

For discussion – the roof needs either a waterproof coating of some description or replacement. If we are successful in our "Solar Panel" Grant we will have to quickly debate the roof situation. Budget-wise there may also be difficulties.
