## 6. Election of New Executive

- 6.1 The President noted that each year the Committee retired in accordance with the constitution, and a new Committee is elected.

- 6.5 New President Peter Ward and new General Member Carl Jackson briefly introduced themselves to members. Carl Jackson has been a member of the Club for about 15 years and plays social tennis and competition tennis. Peter Ward thanked Stewart Back for his many years of service, and everyone on the Committee. Peter believes the Club has one of the best facilities in Canberra. Membership is one of the challenges facing the Club including how to increase membership and making sure members get the most value out of their membership and have a worthwhile experience. Peter thanked the Club and looks forward to working with the Committee.
- 6.6 Former President Stewart Back also briefly summarised the recent President's meeting that was held on 10 August 2020. This meeting was held to discuss the financial viability and income system. All presidents agreed that membership was too cheap and that they should not be paying rates. There was also an issue with club ownership of land/property, however the banks not agreeing with this. The WCTC is long term lease of 100 years, however some of the other clubs have short leases. There was also an issue with facilities as most were originally built in the 70s. It would be interesting to see what sort of courts the new Gunghalin facility will have as Tennis ACT does not prefer grass courts. The President's did not agree that the definition of major assets in the club does not include resurfacing.

### Life Membership – Stewart Back

8.2 Stewart Back thanked the Committee for their support, in particular Geoff, Graeme and Brian, during this period and hope the new incoming President Peter Ward will continue to keep the 'community' focus of the Club rather than a commercial focus.

### Constitution

8.3 The Club's constitution has not been updated since 2003. Under this current constitution, the Club needs to hold a special general meeting (SGM) in order to make any changes. An SGM is held to deal with one subject only, and in this case, it would be the Constitution.

8.4 Graeme Rossiter and Geoff Kotz have made updates to the constitution. They will send it to the Committee for their review and set a date for the SGM to approve the changes, possibly the same date as the next general committee meeting.

8.5 The updates are minor and include document formatting and allowing for changes to be made to the Constitution at a AGM instead of holding a SGM instead.

8.6 Once the Constitution is approved at the AGM, then the Club can lodge it with the ACT Government (Access Canberra, Registrar Office). A lodgement fee will be required.

### Bar Fridge

8.7 WCTC Member Rick Lord advised he would like to donate an old bar fridge to the Club so that ice can be held for injuries. Members agreed and will place the fridge in the back room.

# President's Report

## Welcome to the Annual General Meeting for 2020.

As indicated on our website and emailed to you, the Annual General Meeting for 2020 will be held on Wednesday 19th August at 7.30 pm at the Clubhouse. Please come and contribute to the running of your Club. The Club needs new Committee Members and is under-represented with competition players. If you can participate as a Committee Member, please contact Clair Dupont, Brian Chauncy or myself before the AGM.

We are now in a more fortunate position, administratively, to keep members up to date on activities through the industry of your Club's secretary, Clair du Pont, who adds items of news/interest to the website as they occur.

Hence the Annual Report will be mainly a precis of activities of the last topsy-turvy year.

With the online membership and court booking system, Membership continues to be less than desired. Fees have increased minimally; and we continue to see an increase in casual player fees via the book-a-court system. There are still some frustrations with the now not-so-new system, but thanks to the effort of our Membership Secretary, Brian Chauncy, individual problems have generally been resolved. Should you have difficulties with the online booking or registration system, please contact Brian.

The Committee has, and continues to liaise closely with, ACT Tennis on the future of tennis, and participates in their regular forums and information sessions.

**As we all know this year has been a year of unpredictables. The virus, bushfire smoke, vandalism, court resurfacing, lighting upgrade, grounds and fence improvements, and court maintenance have provided a large workload for several Committee members.**

Our collective appreciation goes to Geoff Kotz for his role in organising loans, grants and work on the lighting upgrade to LED lights with contractors that have caused much angst and effort, the resurfacing of courts 5-8, plus his normal load in keeping the Club's finances going.

The resurfacing took place fortuitously during the pandemic, but the sanding and final levelling cannot be addressed until spring and warmer weather.

Also, with a lot of diligence, discipline and his own time and effort, Graeme Rossiter was able to keep the Club at least partially open. Together with Tim Harris (who had his paint compressor and kit stolen by vandals) their efforts on the fencing and the grounds, are very much appreciated.

With all the day-to day changes and other activities, our diligent Secretary, Clair has kept all members informed on the state-of-play. Your Committee hopes the next year will be much more stable than the last year, on many fronts.

We are still concerned for the serviceability of the Club roof as it continues to leak into the ladies toilet on wet occasions, but we are unable to locate where the water comes from. If we were sure that the roof itself leaks then we would replace it, but there is no assurance that it is the problem.

Also, we are very conscious that the fences are old, rusting and more importantly sliding down the poles and turning up along the base, creating holes and sharp wires. However, we do not have the finances to replace them. Hence Graeme Rossiter has made a big effort to spray the fences black to enhance their appearance and life. We have been advised on how to repair the turned up wire and straighten the bent poles and Graeme, Geoff and Tim will work on that over the next 6 months.

Committee Members have also attended numerous ACT Tennis Forums, held mainly at night, but also, more lately with the virus, online; this has been less, than satisfactory but better than nothing.

During the virus, competition tennis has been suspended, but is now starting up again.

Finally, and not the least important activity, has been children's coaching. Mark Walton and his team have been able to conduct limited coaching despite the restrictions, but some of his activities have of necessity been suspended. However, it is good to see that most normal activities have resumed for the present, and that players are again enjoying "the game for life", and the associated social aspects.

Despite the foregoing, your Committee has not lost focus on tennis itself. Tennis wise, the Club is again open and welcoming to all the community, and the level of activity, even in winter, indicates tennis remains a very popular sport. Juniors, competition, social and casual play is well supported, however, like all Clubs, there continues to be a paucity of players in the 20-40 year age group. There are a number of Tennis Australia and ACT Tennis programs aimed at bringing back those who stopped playing after their initial involvement. While many children receive coaching, this does not translate to those children continuing to play or to them joining the Club. This continues to be a nationwide issue for many sports.

We continue to have two sponsorships for which we are most thankful. The Canberra Southern Cross Club (CSCC) continues the present 7.5% of 'card swipes' at the CSCC venues. We ask all members and their friends, who are members of the CSCC, to "sign up" when they visit any of the CSCC Clubs, and then swipe their CSCC card when they buy food or drinks. (Please note: One does not need to be a member of our Tennis Club - this is relevant to parents of children and any friends).

The Rebel Sports support is also of great benefit in that 5% of "Rebel" purchases are returned to the Club through purchases at any Rebel store. For this system to benefit, any person with a Rebel card and directly identifies our Club, or whose card is annotated "Weston Creek Tennis Club" who makes a purchase and swipes the card

adds 5% to our credit without any penalty to their purchase . The Club uses funds to purchase Club needs – balls, nets, etc- to help reduce the cost of playing. But Rebel does not have sweepers, so the Committee continues to look for better sweepers that last longer and are much less costly (present sweepers are about \$300!). The Rebel cards are available from Mark Walton, Brian Chauncy and myself.

Please support our Tennis Club by participating when you, your family and friends go to either the CSCC or a Rebel Sports store. **Please note:** The Club does not contribute to private groups or individuals whose play is not open to the community at large.

While our financial position is sound on a yearly basis, planning and implementing a longer term sinking fund which provides for new courts, fencing, and a new lighting system and other items, is far from precise. To resurface courts 5-8 required that we obtain a loan from the ANZ bank for \$70K, repayable over 5 years. The remainder of the \$150K needed to 'do' the courts was taken from our bank balance, which is now not looking as rosy.

As all will appreciate, the Club has existed now for almost 50 years and all the major components of our Club – Courts, lighting, fences, Clubhouse, electrical and water systems and grounds, need a major “makeover”. As you have read from the above, 4 courts(5-8), lighting, fences and grounds’ deficiencies have all been addressed, but ensuring your Club can progress facilities’ improvements further, will need substantial government assistance. ACT Tennis and executives of numerous tennis Clubs are addressing this wider issue now.

Your Committee believes that most members want the Club to continue to operate as a Club rather than as a commercial centre; we will try to keep the need for survivability, commercial, viable/Club-like and open, in balance. Affiliation with ACT Tennis brings several benefits, such as competition organisation, player insurance, support expertise in running the Club, and news on various Tennis trends/activities.

Each year I conclude the Report with this reminder - most importantly, Tennis at our Club is a game for all to participate in and enjoy. Your Committee will try to keep it that way. **There is little doubt that playing tennis at all ages contributes to our physical, mental and social well-being, which in turn enhances our quality of life-AKA happiness.**





**INDEPENDENT AUDITOR'S REPORT  
TO THE MEMBERS OF  
WESTON CREEK TENNIS CLUB INCORPORATED**

**Scope**

We have audited the financial statements of Weston Creek Tennis Club Incorporated, being the Statement of Operating Income and Expenditure, Balance Sheet and Notes **for the year ended 31 March 2020**, showing an **Operating Surplus of \$11,239.97. and Accumulated Funds of \$298,177.52.** The Committee is responsible for the preparation and presentation of the financial statements and the information they contain. We have conducted an independent audit of these financial statements in order to express an opinion on them to the members.

Our audit has been conducted in accordance with Australian Auditing Standards to provide reasonable assurance as to whether the financial statements are free of material misstatement. Our procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial statements, and evaluation of accounting policies and significant accounting estimates. These procedures have been undertaken to form an opinion as to whether, in all material respects, the financial statements are presented fairly in accordance with applicable policies described in the notes to the accounts and relevant statutory requirements as outlined in the *Associations Incorporation Act 1991 (ACT)* as to present a view of the entity which is consistent with our understanding of its financial position and the results of its operations and cash flows.

**Qualifications**

As is common for organizations of this type, it is not practicable for Weston Creek Tennis Club Incorporated to maintain an effective system of internal control over receipts until their initial entry in the accounting records. Accordingly, our audit in relation to receipts was limited to amounts recorded.

**Qualified Audit Opinion**

In our opinion, except for the effects on the financial statements of the matter referred to in the qualification paragraph, the financial statements are in accordance with s 72 of the *Associations Incorporation Act 1991 (ACT)* and present a true and fair view of the financial position of Weston Creek Tennis Club Incorporated as at **31 March 2020** and the results of its operations for the year then ended.

### **Notes on the Reports year ended 31 March 2020**

- 1 The club operates on a cash accounting basis, which means all receipts and payments are recorded in the club's accounts on the day the transaction took place irrespective of any portion of the receipt or payment which might refer to a prior or subsequent financial year.
- 2 Assets are recorded at their historical cost and are depreciated, using the straight line method, over the number of years of expected useful life. As assets become fully depreciated and have either been replaced or become redundant they are written off and deleted from the asset register.
- 3 Both Pennant competition income and expenditure figures were down due to cancellations.
- 4 A Grant of \$10,000 from Stronger Communities Programme will go toward the Court Lighting Project
- 5 The increase in expenditure is due to the need to remove the dying Eucalyptus Nicholii and treatment of the elm tree.

# Membership Report 2019-20

## Membership Report for AGM 19 August 2020 addendum

Further to the membership report for the 2019-2020 membership year [1 April 2019 to 31 March 2020] that went to our auditor in April, I wish to add the following information.

At the start of this membership year on 1 April, the Club moved to a pilot version of a club management system named Club Spark. We joined this as a test prior to its adoption by all clubs affiliated with Tennis Australia. The system incorporates financial and membership information as well as encompassing the Book a Court system.

Jake Lalliard from Tennis ACT has been our valuable liaison person and fixer.

The system has been functioning well in general with only minor (mainly operator ie me) problems. It allows members and the general public to find an available court and then book on line. Power black outs, although rare, cause a shut down of the booking system.

Club Spark allows the club to monitor court usage as each person who has booked a court must enter their pin code for the booking, irrespective of whether the gate is open or not. Problems have occurred when players do not leave sufficient time between booking and their desired time of play; about 20 minutes is required. Some players arrive too early for their booking; the key code starts working about 10 minutes prior to their booking. If people wish to cancel their booking, they must do this at least 1 hour prior to the booking if they do not wish to be charged. So, keep an eye on the weather. Some players have complained that the lights don't turn on or go off before the booking has ended. I have not been able to find what the cause was but it happens rarely and again I suspect operator error.

At the start of the year, last years members were migrated to the new system and remained active until the period of grace had expired, when the system should have marked them as lapsed. Updates to the code will make this automatic in the future, but in the mean time this has to be done manually so the numbers in the current list are not necessarily accurate. There needs to be an automated email to members when their renewal is processed or new memberships accepted, but this has been flagged. I have also asked Jake to expand recording of the method of payment to include eft and credit card to replace 'other', which is not helpful to planners.

The new system also includes an email program that seems to operate as intended. So each member should get reminder notices to update their membership or a notice that their membership has lapsed after 1 month ie on 1 May. (the period of grace for renewal).

The courts were closed for *ca* 6 weeks due to the initial Covid-19 crisis but, because of the generosity of our members, this did not seem to affect our membership renewals. Also Graeme provided access to **members** for singles play during this period, which was very much appreciated.

Members in 2016-2017: 345, 2017-2018: 339 2018-2019: 236, 2019-2020: 264. This year we are approaching 300 members and we are only half way through the year. Mark Walton has been active in encouraging his students to join as juniors, who are the future of the club and tennis in general.

One major problem remains, which costs the Club revenue. If a member books a court for free, as he/she is entitled to do and plays with non members but does not collect any payments from them, we loose out. No one knows how to fix this, but fortunately many people are honest and collect the money.

## Coach Report



Hi all, as we all now know 2019 – 2020 has been a challenging time for all so far with bushfires at the end of 2019 early 2020 & now Covid-19, making life very different & challenging. We at CSOT have also been affected, like all of us, from these events, but as we speak we are just happy to be back on the court doing something we love, even if it is in a slightly less normal way. Numbers for coaching would normally be around the 300 to 400 students thru summer & 200 to 300 in the winter time, this would be at least 30% off at the moment. We are currently hoping to do some school work again in term 4, but other events towards the later part of the year have already been cancelled for 2020. These include the Interstate Teams Challenge here in October & the end of year NZ junior tour in December. The Tennis Carnivale Charity Day for RMHC has also been cancelled for 2020 due to Covid-19. We hope to be back with all these programs in 2021. However we are still striving to run as many programs as possible under the obvious hygiene protocols & these are below.

Our main diverse & organised programs include:

- A range of TA endorsed tennis coaching programs which attracts a diverse range of people. From our Hotshots playing & lesson programs for the kids thru to our Cardio tennis programs, Holiday camps & local in house tennis competitions & junior ACT competitions & tournaments.
- We also have a strong connection with our local schools which we feel is vital for our grassroots tennis programs at Weston. We currently have Chapman, Arawang, St. Judes & St John Vianneys already attending our schools tennis coaching activities.



- Open Day Tennis Events – Again something we feel is very important in connecting with the local community is our Tennis Open Days. This has been an ongoing battle for many years but recently Stewart exchanged his four legged white charger for a two wheeled variety. This nearly ended in a catastrophe. Enough said at this stage.

He has also organised mid-year lunches and Christmas lunch for committee members.
