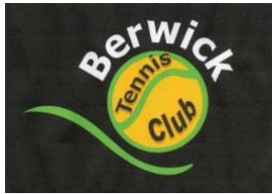

### Item 8 - Resolution 2

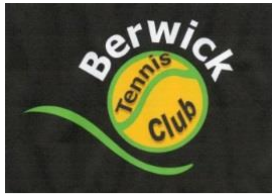

Any member leaving the club following the start of the 2025/26 financial year can pay the following pro-rata exit fee rather than the Full Annual Membership Fee:

- Junior: \$40
- Concession: \$45
- Senior: \$50
