President's report – Simon Clarke

- 1) Installation of the Book-a-Court system, with revenue exceeding expectations (\$900+ in July) and benefits for members and non-members.
- Substantial capital improvements to the clubhouse as a result of a Federal Government grant. Simon thanked Member for Chisholm Gladys Liu for her support through the process. Simon also thanked committee member Jan Buxton for his tireless efforts in project managing the renovations.
- 3) Planning has begun on the second major project associated with the grant which is the installation of LED globes and replacement of some light towers on the northern courts.

Simon thanked departing committee members Chloe Verbeek and Andrew Halliday for their service to the Club.

Questions/comments from the floor included: Graham Forbes - are we registered for GST? Yes, we registered for GST for grant and associated works. Once income drops below threshold we will deregister for GST.

Kim Trengrove - have you done analysis of book a court bookings? Not yet, but we have the ability to do this and will be doing this, and we will also be undertaking an online marketing campaign. Sugumar Mariappanadar - two streams of income is good; members and book-a-court Danger too many members converted from Book-a-Court. Needs to be a balance - two streams. Simon agreed, however stated believes we have scope to increase membership, maybe 280 – 350. There is capacity. But yes, important for two streams of membership

Simon also made special mention of 125th anniversary of BHTC; looking to commemorate at the December Christmas Party as unable to hold celebration dinner as planned.

Peter Wright outlined the work he and Rod Petrie have been doing as they clean out and collate 40 + years of Annual reports and meeting minutes. Peter and Rod undertaking process to scan and organise. Peter thanked Kim, Simon C, Simon V for assisting. And reiterated it is important we celebrate the longevity of the Club appropriately.

Message from President: Simon Clarke

This year Box Hill Tennis Club celebrates its 125th Anniversary. The club was initially formed as part of Box Hill Cricket Club and the first courts were constructed in September 1895 on the recreation reserve adjacent to what is now Box Hill High School. The Committee had planned an event to commemorate this, however that has been put on hold due to the Covid-19 pandemic. We hope to still commemorate this at the end of this year.



As for everyone the last year has been one of ups and downs for the club. We have had significant improvements to our facility, and we have been affected by the disruption of the first half of 2020.



In the second half of 2019 we received a large grant from the Federal Government for the refurbishment of the clubhouse and the upgrading of the court lighting. I would like to record our thanks to the federal member for Chisholm, Gladys Liu, for securing this funding. To this point we have been able to renovate the bathrooms, replace the clubhouse windows and doors with modern structures, paint the exterior of

the clubhouse and replace our gas heater with an efficient reverse cycle system. The next stage will be to replace all the halide court lighting with LED lights and replace the four tall light towers with towers similar to those on the other courts. Currently we are awaiting a planning permit from Whitehorse Council to undertake this, which we anticipate completing by November 2020. The Committee views the lighting upgrade as an important undertaking, as it will significantly reduce our power bill, which is one of the major costs for the club.

The other major change for the club in the last year has been the introduction of the Book-a-Court system. I would to thank members for their patience in putting up with the hiccups in rolling out this system. Hopefully most of those have been overcome, and the system seems to be working relatively smoothly. The installation of Book-a-Court was supported by funding from Tennis Australia and Federal Government. We anticipated that this system would



earn the club \$2000-3000 per year, which would mean we would recover our investment with one year. However, within the first half of this year we have already earned almost \$1800. As well as the income this provides for the club, this will hopefully be an important source of new members.

The attendance at the 2019 Christmas event was fantastic, and everyone had a great time. It provides us with a tremendous opportunity to meet with members and to acknowledge the achievements of players and volunteers. The Committee had planned to extend the social and fundraising activities; however, those plans are currently on hold.

Finally, I would like to thank the efforts of the Committee over the last year. To our Vice-President, Simon Verbeek, for supervising Pennant tennis and wrestling with BAS. To our Secretary, Richard Scott, for the smooth running of meetings and keeping us honest. To our Treasurer, Chloe Verbeek, for her clear and efficient management of finances. To our Membership Officer, Jill Ross, for the myriad tasks in maintaining and growing our membership. To our Head Coach, Alexei Demajo, for supervising our fantastic coaching and junior programs. To Jan-Paul Buxton for his work in facilitating the refurbishment of the clubhouse, and to Rod Petrie, Robert Lane and Andrew Halliday for the lemon iced tea, and their willing assistance with grants, and at committee meetings, working bees and club functions. And although they are not on the committee, I would like to thank Allan Edge for the management of the BDNTA teams and Philip Thompson for the management of the ERT Seniors teams.

Maintenance Report

Over the last year we have had four working bees. The main tasks have been:

- * Regular grooming of the courts.
- * Installation of new nets on the upper courts.
- * General maintenance of clubhouse and environs.
- * Repainting the lines in carpark for possibly first time since they were laid in 1966.

I would like to thank all the club members who volunteered their time to help with these.

Awards and Recognition

Senior Club Member of the Year: Jill Ross

Jill Ross has been actively involved with Box Hill Tennis Club since the start of this century, when her children starting playing junior tennis. She has served on the Social and Fundraising Subcommittee, including as coordinator, and has been a Committee member since 2015. Since 2016 she has been Membership Coordinator and has transitioned our membership from a spreadsheet based system to the current online system. This was a very significant task, and during that time she has also managed the usual membership tasks with efficiency and civility.



With her gentle leadership style she always manages to rally support of willing helpers at working bees, club functions and generally reaching out to members. If there is large scale catering to be organised Jill manages this with a self-sufficiency and enormous capacity that is awesome.

Jill Ross is a model volunteer that Clubs rely on.

Life Membership: Kim Trengrove

Kim Trengove joined Box Hill Tennis Club in 2002, at the same time as her sons started playing at the club. She joined the Committee in 2004 and has served on the Committee continuously since then. She is now stepping down after 15 years of continuous service to the club.



During that time, Kim has served as:

* Convenor of the Social and Tournament Committee from 2005 to 2007.

- * Served on the Selection Committee and Junior Committee.
- * Editor of the Club Newsletter 2007-2012.
- * Committee Secretary 2013-2019.

Kim also has a very strong record as a playing member of the club, in the ERT and Victorian Pennant competitions.

Highlights of her playing career at Box Hill include:

* Captain of the Women's Pennant Team from 2005, including winning the Grade 5 Women's Pennant flag in 2007. This is the only success Box Hill has had in this competition in 50 years.

* Winner in 2004 with Charlotte James of the Club Women's Double Championship.

In recognition of her achievements, Kim was awarded the Club Member of the Year for 2007. And for her continuous service to the social, administrative and playing life of the club, she has been made a Life Member of Box Hill Tennis Club.

BHTC Junior Club Member of the Year: Tim Wilson

He has also been a part of the coaching program for the past 9 years. He has consistently been a team captain, participated in Club events and over the past 12 months began learning what it takes to be a coach with Future Demand Tennis. He has also devoted a great deal of the year to be trained in the art of stringing which he hopes to take on independently in the near future. The Steve Collett Award was awarded to Hugo Halliday for 2019. Throughout the past couple of years Hugo has worked extremely hard on his game which has seen him play Rubbers 1 on a Sunday and up to Rubbers 8 on a Saturday. He has also been selected to represent the Eastern Region in their Association Junior Leagues (Junior Pennant) over the past season. This competition brings together the best kids in metropolitan Melbourne to compete on a weekly basis.

Hugo attends our weekly performance squad on a Friday, he has a weekly private Lesson with Raveesh plus Hugo has also devoted time to athletic development by joining our Athletic Development program at the club.

He can also be seen regularly practicing during the holidays with his great friend Dylan!

We hope that this award will continue to inspire Hugo to keep up the hard work and continue to take his game to the next level!

Reports

Membership Report: Jill Ross

Our membership for the 2019/2020 financial year continues to be strong, with the total number of members being 286, which is a slight decrease from the previous year (301) and this can be contributed largely to the inability to run competitions such as pennant due to Covid-19.

Once again, I would like to thank the following contributors who through their continued commitment and efforts, enable the membership of the club to remain healthy:

- A vibrant night tennis competition, coordinated by Allan Edge
- An excellent coaching program provided by Alexei Demajo (Future Demand Tennis)
- Coordinator of Saturday/Sunday ERT and Pennant competitions, Simon Verbeek
- The Committee, led by President Simon Clarke, who give up many hours to ensure that the membership have access to fantastic facilities at BHTC



Each year we are seeking to improve the membership administration in the hope of reducing the amount of time and effort spent recovering membership fees. We will continue to use the 'My Tennis' portal to send out invoices for the upcoming membership year with a view to investigating other options.

The process for new members to join the club has been revised and as such we now request that no payments for membership are to be made until the following processes are completed:

- A new membership form is to be sent to the Committee President and Membership Officer for approval
- The form is to be tabled at the monthly committee meeting
- Once approved, an email is to be sent to the potential member providing payment options

All members will receive their 2020/2021 membership renewal invoices in the weeks following the Annual General Meeting and will have 4 weeks to complete their payment. It is therefore important that all members advise the club of any contact detail changes, especially email addresses as this is our key means of communication within the club.

Coaching Report: Head Coach Alexei Demajo

Despite the COVID19 interruption the coaching program has continued to grow over the past year with over 230 players participating in lessons during the week and on weekends. Our Hot Shots Blue and Red Stage program (3-8 years of age) continues to thrive with extremely high numbers taking lessons. This bodes well for a long term sustainable program and growth for the club. Our Performance Program Pathways have continued to develop as we now deliver Invitational Squads at Orange & Green Ball Level to complement our squad program from our older athletes. We recently staged our first Interclub challenge match with players from Box Hill TC competing against players from Gracedale Park TC, HE Parker Reserve TC in a Home & Away format playing Doubles and Singles over the two weeks. The tournament was a huge success and we look forward to growing this concept in the future.



We continue to develop our players with 10 players representing the ERT in last season's Junior Pennant (AJL) and similar numbers nominated for the 2020 competition (providing it goes ahead). We continued our strong relationships with local primary and high schools delivering Sporting Schools programs to Roberts McCubbin PS, free clinics to the Kingswood College Junior School and running the Kingswood College Senior School (Yr 7-12) tennis program. Our Summer installment of the FAST4 Adult In House Doubles Comp was a big success despite some heatouts and washouts during the very weird summer period. Unfortunately, due to COVID19 the Winter installment was not able to go ahead.

Looking ahead to the upcoming year we are aiming to achieve the following goals:

- Deliver a new girls only program designed to introduce 10-14 year olds to the sport and progress them into competition tennis
- Continue to grow our Performance program by adding the missing Invitational Squads to our Tennis Pathway at Box Hill TC
- Maintain the high number of Junior Teams representing the club in weekend ERT competition
- Introduce and maintain a sustainable Cardio Tennis Program for Adults at the club
- Further growth in regard to Tournament offerings at BHTC and the potential to stage an Australian Money Tournament in the next year.

Junior Competition Report: Head Coach Alexei Demajo

Box Hill TC continues to be one of the top two premier clubs in the Eastern Region when it comes to ERT Junior Teams participation. Over the Summer 2019/2020 season the club entered 32 teams in the Saturday and Sunday morning competitions with sections ranging from Rubbers 2 through to entry level Red Ball Doubles. Throughout the year, we continue to attract new players predominantly due to the fact that we have an expansive range of sections on offer and the positive environment they have experienced when playing at BHTC in the past. Our Winter numbers historically drop due to the high number of players who play football with team numbers between 21-24. Unfortunately Winter 2020 season has been cancelled due to COVID19.

We are looking forward to a big Summer Season so all the kids can get back to competing.

ERT Seniors Competition Report: Simon Clarke

Thanks to Philip Thompson for being ERT Senior Coordinator over many years. Philip stepped down this year due to family responsibilities.

In the Winter 2019 season Box Hill only had one side in the Saturday afternoon OS6 division. This team captained by Allan Edge won the Grand Final.

In the Summer 2019/2020 season in the Saturday afternoon competition Box Hill had two teams in SD2, and one in each of SD3, SD6 and OS5. On Sunday afternoon we had one team in the OSD1 division. The SD6 team captained by Will Thompson won their Grand Final. The SD2 team captained by Calum Kennedy-Moore lost to St Marys in the Grand Final, while the OS5 team captained by Allan Edge and the OSD1 team captained by Calum Kennedy-Moore lost in the semi-finals. Congratulations to all teams on your seasons.

Unfortunately, the Winter 2020 season has been cancelled.

Night Tennis Report: Night Tennis Convenor Allan Edge

- There are over 120 regular night players, plus other emergencies

- We were able to move matches to Eley Park last season and, if additional capacity is required to prevent court overloading, we have agreement to do so in the future for midweek matches.

Pennant Report: Simon Verbeek

The Box Hill Tennis Club had four teams participating in the Tennis Victoria Pennant competition. The club entered teams in grade three, grade four and two grade seven teams. All teams were competitive in their grading and in particular the grade four team, which made it through to the third weeks of finals.

Treasurer's Report: Chloe Verbeek

The 2019/2020 has been an exciting year for the club from a financial perspective with the club receiving four grants totalling \$153,089 (including GST). Of this, \$143,000 is in relation to the refurbishment of the clubhouse and the installation of new lights towers and LED globes. To date the club has spent approximately \$82,500 of the refurbishment grant with the remainder planned to be spent in 2020/2021.

To receive the grants the club was required to register for the GST and complete quarterly Business Activity Statements (BAS). As part of this requirement, the club has had to pass on any GST it receives to the ATO minus the GST it has been charged.



During the year the club transferred \$60,000 from the redraw facility into the operating account to have funds available to make payments for the refurbishment costs to assist in progressing the works. Consequently, the club's loan increased with a current balance of \$76,570 and the savings account has increased to a current balance of \$159,794.

In the 2019/20 financial year, Box Hill Tennis Club made a surplus of \$82,492. The surplus is primarily due to the following:

- The club received the following grants:
 - o \$143,000 (GST Inclusive) Australian Government
 - \$3,089 (GST inclusive) Victorian government Active club grants
 - \$1,000 Victorian Government
 - \$6,000 Tennis Australia Book a court
- Insurance payment of \$6,480 due to damage to the clubhouse from the hot water system leaking.

Much of the surplus is unspent funds committed to the refurbishment costs that are expected to be completed in 2020/2021.

When you factor out the refurbishment grant and the associated costs, the club has effectively operated the year with an approximate surplus of \$21,000. This is down on previous years, which is primarily due to COVID 19.



COVID 19 has had a significant impact on the club's income with reductions in the following items:

- Membership (approximately \$4,100)
- Night tennis (approximately \$3,900)
- Court hire (approximately \$6,000)

COVID 19 has also reduced our expenses for the following items:

- Association and team entry fees (\$1,895)
- External court hire (\$727)



'Book a court' was introduced during the year which allows the general public to hire the courts online. The cost to purchase and install this was approximately \$12,000 and the club received a \$6,000 grant from Tennis Australia as an incentive to have it installed and make tennis more accessible to the general public. This has provided the club with additional income of \$1,724 since it commenced in early February 2020. The club is experiencing a healthy growth with hire fees from 'Book a court' and the system is expected to pay for itself in the not too distant future and provide the club with ongoing income.

The City of Whitehorse rates notice this year identified the site value of the club at approximately \$5 million, which is significantly up since the last site value of \$3.13 million.

The strong financial position of the Club has been made possible due to the following contributors:

- Simon Clarke (President) who generously provides much of his time to identify and pursue grants, manages projects and tirelessly researches initiatives for the betterment of the club.
- The number of committee members who contributed much of their free time in completing applications for grants that required written submissions, quotes and numerous meetings.
- Anne Smyth (Club Bursar) who does a tremendous job in collecting and banking the cash received from night tennis, memberships and ball fees.
- Jill Ross (Memberships) for collecting membership fees, on boarding new members and overall management of memberships. The membership fees continue to be a large portion of our income.
- Allan Edge (Night Convenor) for organising a large number of night teams which brings in a significant income of \$14,158.

Thank you to the committee and members for their work and contribution towards Box Hill Tennis Club's healthy financial position.


