Burnt Bridge Tennis Club - Rules for use of Courts by Keyholding Members

Tennis purposes only

The tennis courts at the venue are only to be used for the purpose of recreational tennis. You are not permitted to use the tennis courts at the venue for any activity other than recreational tennis without prior written agreement of the Club. Professional coaching on the tennis courts may not take place, other than by approved persons, who have the prior written agreement of the Club.

The front gate should be kept shut at all times so passers-by cannot wander in.

Check in, sanitise and bring your own water bottle.

Courts are available for casual play during daylight hours only. There are night competitions running from 7.15 pm to 10.30 pm Mon to Thursday on alternate weeks during school terms and on Saturday mornings all courts are being used from 8 am to 1 pm. The night competitions are playing away half the time so please check the website for match rosters if you wish to play in the evenings. Coaching runs most weeknights from 4 pm to 7pm but often some courts are available.

Children

Children under the age of 16 must be supervised by an adult (usually parent/guardian) at all times during their use of the venue.

Damage

Users of the tennis courts must not damage, deface or mark any part of the venue. By using the courts you agree that you will be fully responsible and liable to Club for any damage caused by you to the venue.

Other users

Members are welcome to invite friends to play with them at BBTC **on payment of a visitor's fee of \$5 for each player over 12 years of age. Pay online directly into the bank account listed under membership or place the \$5 in the box at the clubhouse door in an envelope with name on it.**

When using the courts keyholders agree that they will ensure all users of the venue comply with the stated terms and conditions and that they will remain fully responsible and liable for any breach of these terms and conditions by any user of the venue.

Safety

It is a condition that users of the tennis courts undertake to use the facilities in a safe and cautious manner at all times.

Risk Warning

You acknowledge that by using the Burnt Bridge tennis courts you will be exposed to certain risks, including the risk of physical injury and that use of the tennis courts is entirely at your own risk.

BBTC Members are covered by Tennis Victoria Insurance when playing but guests are not covered. The incident book is to be used to report injuries if the clubhouse is open otherwise a member of the Committee (secretary@bbtc.com.au) needs to be notified ASAP after the incident. The incident book is kept next to the First Aid box in the kitchen area.

Player Etiquette

Please take all your rubbish with you and leave the tennis courts and facilities tidy for the next players to use and enjoy. Early morning and late evening players please be mindful of the local residents who live nearby. Try to keep noise on the court to a minimum. Smoking is not permitted within the fenced area of the venue.

Footwear

All users must wear appropriate tennis footwear at all times when using the tennis courts at the venue.

Maintenance of the courts

The courts need to be watered prior to play and during play if they are dry and dusty.

Clubhouse

The clubhouse will not be available out of competition and coaching times. There are public toilets outside the venue if needed.

Release

To the fullest extent permitted by law, you agree to release and discharge Burnt Bridge Tennis Club and its directors, officers, employees, volunteers and agents from all liability in respect of any loss or damage you may suffer from use of the tennis courts.

I, the keyholder, have read and understood the conditions of use of BBTC courts and the risk warning outlined and accept and assume the inherent risks in use of the tennis courts.
