COURT BOOKING - TERMS AND CONDITIONS

By making a booking, hirers confirm that they have read and agree with the Terms and Conditions, which will apply to the hirer and those playing under the hirer's booking.

COVID-19 Guidelines

In making a booking, the hirer confirms that they and those playing under the hirer's booking comply with the current government COVID guidelines and shall maintain the recommended social distancing.

In particular, players must stay at home if they are unwell, have flu like symptoms, have travelled and not met full quarantine requirements or have been in contact with someone with COVID.

Bookings – General Information

All players, whether Members or non-members, will be required to book a court in order to play, even where Members have access to free court hire. No access will be allowed without a booking. The only exception is club events, pennants, coaching and school bookings, where the club or the coach will book the courts for the events. Private coaching is not permitted. All coaching shall be undertaken exclusively and only by the Club appointed coach. Please contact the Club Committee should you require further information about coaching.

The order of priority for court usage is:

- 1. Pennants and tournaments
- 2. Booked groups (such as school bookings)
- 3. Coaching and squads
- 4. Club organised social play
- 5. Member bookings
- 6. Non-member / public bookings

There may be instances where Pennants teams require access to additional courts that have been booked by Members / non-members. In these instances, Pennants teams will have priority, a credit will be issued if other courts are not available.

Maximum booking is 3 hours.

Lighting fees (\$5/hr) are to be paid through the court booking system for all evening bookings, including for Member and non-member bookings. Lighting fees will apply on a seasonal basis as below:

1 May to 30 August: 6pm onwards
1 September to 31 October: 6:30pm onwards
1 November to 27 February: 7pm onwards
28 February to 30 April: 6:30pm onwards

A court booking is not complete until the booking process is finalised, including payment of court hire fees where required. A confirmation email of the booking will be issued to the hirer of the courts.

All players shall abide by the KTC Rules as provided on the club website.

Member Bookings

Annual membership fees entitle Current Members to free day time play. A cost of \$5/hour per court is to be paid for lights for night time play, in accordance with the KTC Rules.

Members will be required to book courts through the booking system, whether playing day or night. Current Members will be issued with a membership code to enter into the booking system to gain free access to the courts, however, payment of lights will be required through the booking system for night time play.

Any member found providing their code to a non-member may have their court hiring privileges revoked.

Each member can only book one court at a time.

Members and Guests

Guests of Members are welcome. If Members bring an occasional guest, they may play free of charge, providing they are playing on the same court as the Member.

A Member can bring a guest up to 3 times during the membership year. If the Member's guest's play becomes regular, the Member shall pay the fees for guest play. Costs for guests is \$5 per hour (note that this is \$5/hr not \$5/hr/guest – 1, 2 or 3 guests are welcome at a total of \$5/hr). Members shall pay for guests as part of the booking process. Guests of Members can only play when accompanied by the Member.

To add a Guest to your booking, on the second booking sheet (after confirming booking time), Go to the "Players" window and select "+ ADD PLAYER", "Choose Player" from drop down box, enter their name and select "Guest" option.

Note also that if you require more than one court when playing with guests, then a guest needs to book the additional court/s. Members are not permitted to book multiple courts for the same time under their membership.

Casual Play / Non-Member Bookings

Non-Members are welcome to make casual bookings. The booking system will take payment at the time of booking. The fees are \$10/hour per court through the day and \$15/hour per court at night to include for the cost of lights.

Club Organised Social Play

Club organised social play (Wednesday morning, Thursday and Friday evening) will be block booked by the club. Normal participation fees for Members or non-members will apply.

Playing Over Time

It is the responsibility of the hirer to finish play at the designated time. Where a court is vacant at the expiry of the booking period, the booking may be extended, and an additional charge will be payable, including the cost of lights for Members.

Cancellations

Please use the link in your email confirmation (Members may manage bookings through their Member Portal) to change your booking.

Cleanliness

It is the responsibility of the hirer and those playing under the booking to remove their rubbish from the courts, to ensure the courts are clean and tidy for the next players.

Lights and Security

The club currently does not have an automated lighting system. The light switches for courts 1-5 are located at the main club house to the right of the toilet door, and at the top of the wall. The light switches for courts 6-9 are located adjacent the small club room near those courts. The last players on court shall ensure that ALL lights are turned off and gates are locked using the padlocks on the gates.

Safety

The club reserves the right to cancel bookings for safety concerns, including weather events. Court hirers will be contacted directly if such a situation occurs and a credit given for future use.

While Kardinya Tennis Club does everything it can to guarantee safety of players and visitors, it is unable to guarantee first aid support will always be on site. By booking the facilities, the hirer acknowledges, it is the responsibility of the hirer to have their own first aid supplies and are using facilities at their own risk.
