### **Umpires for juniors:**

Umpires shall officiate Section 4 finals. Wherever possible these should be neutral, eg in the first final persons from 1v4 ideally should officiate in the 2v3 match and vice versa.

*Georges Creek will provide some umpires for the GF but they are limited, so some parents may need to assist, especially with Section 4*

### **Additional notes**

#### **Paper scoresheets**

All clubs are required to bring their own paper scoresheet, with their team filled in and the reserve player(s) listed on the back of the sheet. This is the same as previous years.

Clubs can use either a print-out from Match Centre or a scoresheet from last season.

#### **Tie-breaker for Section 3 & 4**

If scores are even in Section 3 & 4 – a super tie-breaker (to 10) must be played. It is to be doubles and teams can select any player combination including their reserve player.

#### **Eligibility**

- a. Teams need to make sure their players are eligible to play, this can be done by checking Match Centre.
- b. By-law change 2023/24

By-law 6. f. i. is:

For the 2023-2024 season for this not to apply for juniors playing in section 1 and 2 providing the player must still play more than half the scheduled matches in the lower section.

#### **Section 4**

All players should attempt their first serve from the base line, they can then move forward between the base line and serve line on their second serve if they need.

Umpires will call scores and assist with line calls etc., it's not a coaching role per se.

#### **Section 3 semi-finals**

Players and spectators are to stay off the stairs at Tangambalanga. Parents and clubs are asked to manage their own players and supporters in this matter.

#### **Reserve player for Section 1 & 2**

A woman can be named and play as the reserve for the men in Section 1 & 2
