

Terms & Conditions of MVTC

By becoming a member of MVTC (completing the Joining procedure) you agree to abide by Constitution, Policies, Procedures & decisions of Morphett Vale Tennis Club, including those below. For more information about Constitution, Policies & Procedures & Contacts see our website.

PARENTS/GUARDIANS RESPONSIBILITY

For Juniors (under 18yrs), a **Parent/Guardian is always expected to be present** court side while playing tennis at the club whether it will be competition, training, social tennis, or any other tennis playing activity. Whilst the Club Volunteers will do their best to monitor and supervise Junior players, the Club takes no responsibility for Children whilst at the Club, whether they are club players or other children. Should a Child require transfer to a Medical Facility and the Parent/Guardian cannot be contacted, the child safety will take precedence and an ambulance will be called **at the expense of the Parent/Guardian**.

MEDIA

The club has a policy which **allows publishing of members' photo/video** and **allows inclusion of their First Name & Surname** to be used for promotional purpose unless the President is notified to the contrary before start of the season. In that case we would also ask members not to include themselves in any photo/video whilst representing the club.

PAYMENT

By becoming a member of MVTC you agree to pay the fee of your chosen Membership by the Due Date. If you have difficulty with it, please contact the President to discuss other options/Due Date. If the fee remains unpaid the Committee will consider recovering it on case-by-case basis.

All **one-off payments** (e.g., Competition Members) are to be done by EFT banking transfer to the club's account:

All **pay-as-you-go payments** (e.g., Social Tennis) are to be processed according to club's ability at the time of payment.

CANCELLATION POLICY

There are times when players need to withdraw from the Competition for a variety of reasons beyond their control. **Always consult with the Junior/Senior Manager or President to see if a replacement can be found before making final decision.**

If the decision to withdraw from the competition is made, then the club has the following policies for refunds:

- 1. Withdraw after joining and before the 1st round of the season:**
Refund 70% of the membership fee. Club keeps 30%.
- 2. Withdraw after the 3rd round of the season:**
Refund 50% of the membership fee. Club keeps 50%.
- 3. Withdraw any time after the 4th round of the season:**
No refund. Club keeps 100% of the full membership fee.

If the Club has not received the portion of the fee to be kept by the club by the Due Date, the Committee will consider its recovery on case-by-case basis.

SPECIAL CIRCUMSTANCES

Players that have used a valid Sports Voucher as part of the fee do not qualify to receive a refund.

Other special circumstances can be considered by the Management Committee on a case-by-case basis.
