2. **Woodend Home Matches:** requested for warm up at 6:45pm for **7:00pm start**. Captains to confirm.
3. **Mt Carmel Team 3 / Section 4 – Gold:** all home matches to be played at **South Gisborne**
4. **EMERGENCY PLAYERS NOT LISTED MUST OBTAIN APPROVAL PRIOR TO PLAY** as per MRTA by-laws. All players, including emergencies, must be registered with Tennis Victoria and members of a club within the Shire. Players are requested to arrive at **7:15pm** for warm-up for commencement of play at **7:30pm**. Where possible, please try for alternative warm up/start times in particular at congested courts. Reported late starts are subject to point deductions. (Home captains to remind opposition captains prior to each match)
5. **Scores & results for all matches are to be entered online by the HOME TEAM by 8PM MONDAYS.**
Reported and proven late submission of scores are subject to point deductions.
Scores must be entered online via: www.tenniscores.net (Note: Internet Explorer must be used)

6.  **MRTA Thursday OPEN COMP** for the latest up to date information
7. All matches are to be cancelled on **Total Fire Ban** days. (No tennis to be played).
8. COVID related issues will be addressed by the Thursday Night Coordinator accordingly and within compliance with the Victorian Govt, TV, MRSC and surrounding Council where applicable.
9. All players must comply with MRTA by-laws and MRTA Code of Conduct.
10. Zero tolerance of alcohol, racquet abuse and player abuse on the court. Committee to be advised of breaches.
11. Teams will be fined **\$20** for any forfeits, as per the MRTA by-laws.
12. Teams finishing **1st & 2nd** on the ladder after the final round will be awarded a **home semi-final**.
13. In the event of a **semi-final washout** before a winning result is reached, the team that finished highest on the ladder after the final round will progress to the grand-final. Matches are not to be rescheduled.
