Financial Year 2021 – 2022

## President's Report

We are slowly catching up on lost time due to the Covid pandemic. It is pleasing and imperative that we are able to report on the last year a bit closer to the end of that year. Our last AGM on 30 January 2022 was reporting on the year ended 30 May 2021. We are now reporting 30 May 2022 in August and plan to have next year's AGM even closer to the years end (given that we have no major outbreaks).

Thank you to all the members for their patience over the last few years, as we worked through the difficulties that the pandemic brought.

Although the club's financial position is in a familiar state to previous years, it is a continuing aim to increase our sinking fund to be assured of future improvements and to counter any surprise developments. We had an expensive replacement of just 1 court light this year and need to aim to be in a position if similar repairs occur again. I will expand further in our 5-year plan.

Increasing Membership will become an important focus for our committee and our club. We have 6 courts that can service many more members and that also brings additional finances as well as a more vibrant club. A great help will be for members to introduce friends to the club with a view to becoming members. We are aiming to increase our night and day competition teams and new members will be encouraged to play comp.

Prior to recent court hire arrangements, the club had approximately 450 social court hours available per week after accounting for night and Saturday competition. Coaching took about 35 hours per week leaving more than 90% of court availability for members. Even with our recent increase in court hire arrangements we still have over 80% of court availability for members. Keep in mind with our current membership that we have approximately 19 members per court. Some nearby clubs have between 80-100 members per court.

The new website is now active, and I encourage all members to visit and utilise the information and we will be searching for resources to help populate and make our website (and Facebook Page) more popular. I would like to thank Kenneth and Christian for their work in making this come to fruition.

The courts are still in excellent condition. Many thanks to all those that help keep them in order and especially Ian Peter-Budge for his constant maintenance. Thanks also need to go to Maureen Jennings, Chris Simpson and Barbara Lee for doing all those things in and around the clubhouse that we all take for granted. Also, our thanks to Peter Lee and Charles Philactides for constantly maintaining and keeping the courts clean, tidy and in shape for play.

We are constantly searching for the right formula for increasing social use of the courts - especially on Sunday. With the help of our coaching team, we will continue to search for some ways to bring members down for a social hit and to bring a friend.

The committee commenced the preparation of a 5-year strategic plan that has recently been finalised. I look forward to presenting this document at the AGM.

Thank you to all the committee for their work and contribution to the club. We have worked our way through a very difficult period as well as a period of positive change.

I would like to make a special thank you to Fred Van Gorp and Adam Dewhurst for their contribution to the committee. Adam has offered his voluntary services to continue the push to encourage social tennis.

I would like to thank all the members for their support of the club and the committee. NBHTC is a wonderful facility in a special location. Our layout is unique in that the courts have very little distractions behind. This is especially evident during play under lights. The surrounding park lands create a pleasant bush type setting, and we have ample immediate parking facilities with no passing vehicular traffic or noise.

Again, the continuing success of the club depends on the members involvement and care. Please use your facilities as much as possible and have a go at introducing a friend to the club. The membership fees have been discounted heavily this year due to the Covid pandemic impact of the last 2 years, but even at a new member's fee of \$180 per year, I believe it is great value for money for the facility. A special thank you to all those members that chose to renew their full membership effectively donating the discount back to the club.

## Treasurer's Report

The financial report for the year ending 31<sup>st</sup> May 2022 follows.

At this date the Club had a total bank balance of \$38,518.94 compared to \$30,835.77 for the previous financial year.

There was a significant drop in membership fees as compared to the previous year. More than 20 Members did not renew their memberships.

This decline in membership fees was offset by:

- Hiring of courts to Canterbury Tennis Club for ERT and BDNTA competitions for the amount of \$2,314
- State Government grants totalling for \$2,500 for COVID support.

The Club also received the following grants:

- \$635 from the Whitehorse City Council for the purchase of an overhead projector and screen which is used for Committee Meetings.
- \$2,000 from the State Government for a strategic planning workshop for the Committee, to be facilitated by Clubmap during 2022 23.

The court maintenance costs are higher than the year 2020 -2021 but are comparable to years prior to that period.

There was an extraordinary expense for the repair of one light fitting on Court 2 for the amount of \$962.
