5. **Honorariums:**

PTA committee has suggested the following honorariums be paid to committee volunteers for the work done in the last 12months

Secretary - \$5000 Treasurer - \$3,000 League Manager - \$3,000 Junior Liaison - \$4,000 Open Liaison - \$750

Midweek ladies Liaison - \$1500 Rep Events - \$300 per event

The amounts were queried based on previous payments and explained the volume of work, addition of new events and hours required justified an increase to the honorariums. It was noted that due to a change in job descriptions the leaguemanager payment will not be required in future as that role will be incorporated into the Liaison position.

The idea of a more regular payment to committee members either 6 monthly or quarterly was raised. The consensus was that this was acceptable and acknowledged this would require a change to the constitution and the setting of Honorariums for the forward period as opposed to the current system of paying in arrears. The PTA will forward a written proposal to clubs for consideration and voting.

The PTA will investigate working with Bayside and other Associations for possible solutions and playing opportunities. Agreed a sub committee would be formed to come up with possible solutions. Bruce Weatherley, Andrew Cowan, Steve Foot, Courtney Smith and Grant Weir to form the core of the sub committee.

8. Presentation by Tennis Victoria - Kelly Smith (Regional Manager) & Georgia Wise (Club Development Officer)

Georgia introduced herself as the new Club Development Officer for our region and encouraged clubs to reach out to her if they need any assistance.

Kelly introduced herself as the Tennis Victoria rep in charge of implementing the Child safeguarding officers and Member Protection officers at clubs. She explained we all have a role to play in protecting children and creating a safe environment for children at our clubs. Summary of Proposed Constitution changes

Division 1 – Membership ... (page 6)

2. Who is eligible for membership

All clubs who are interested in and support the Association's aims and objectives are eligible for membership. Only Clubs who are affiliated with the PTA and Tennis Australia will be eligible to enter teams in the PTA Competitions. Clubs must maintain valid affiliation throughout the year. Should affiliation lapse no further matches can proceed.

41. Composition of Committee ... (page 15)

The Committee will consist of the positions listed below -

- (a) A President
- (b) A Vice President
- (c) A Secretary
- (d) A Treasurer
- (e) A Junior Liaison
- (f) A Senior Liaison
- (g) A Mid Week Ladies Liaison
- (h) A Representative Events Co-ordinator
- (i) A Coaches Liaison
- (j) A Technology Liasion

Remove League manager as a role - League manager now integrated within comp liaison roles.

46. Who is eligible to be elected...(page 17)

A financial member of an affiliated member club is eligible to be elected or appointed as a committee member if the member –

- (a) Is over 18 years of age or over;
- (b) Is entitled to vote at a general meeting;
- (c) Has no outstanding debts to or within the PTA or any club associated within the PTA
- (d) Does not sit on the committee or board of more than one Region or Association.

Replace d with - Does not present a conflict of interest with another Region or Association

50.Election of ordinary members...(page 18)

(5) A maximum of two members from one affiliated member club shall be elected to the Committee.

Replace 5 with - A maximum of three members from one affiliated member club can be elected to the Committee. Where any affiliated club has more than 2 representatives on committee then voting rights are limited to 2 persons only.
