Player/member photographs may appear in publications relating to the Two Wells District Tennis Club and the Gawler Tennis Association such as club newsletters and local newspapers for the purposes of acknowledgement and commendation only. Photos may also appear on the Club's Facebook page or Instagram page. Any objections need to be advised to the club and/or association in writing.
- That for Family Memberships, each person named will also be bound by this agreement and that they will become a registered player in the national online tennis platform, My Tennis and will be set up with a My Tennis online profile. Any communication from Tennis Australia or other parties can be unsubscribed in the settings of the My Tennis online profile.
- That membership fees are non-refundable (even if a membership is varied, suspended or cancelled) and my membership is not transferrable.
- To be responsible for transport to and from all tennis related activities run by the Club.
- That my child/children are only to be transported by another person with prior written authorisation from the child's parent/guardian and an affiliated club committee member. This is part of <u>Tennis Australia's "Safeguarding Children Code of Conduct"</u> (click to follow link).
- To use correct footwear and protection against the weather, including sunscreen, hats and jumpers.
- That playing, observing, training for tennis and participating in any activity carried out by the club are activities that inherently involve risk, and that in undertaking these activities players do so at their own risk.
- That the TWDTC, including any of its officers and/or members shall not be held responsible for any accident, illness or injury sustained while playing, training, coaching or attending any function with TWDTC.
- To disclose any important medical information to the committee of the TWDTC Inc. and relevant treatments or procedures.
- To authorise the Two Wells District Tennis Club Inc. represented by a coach, team manager or official to call an ambulance and/or to obtain further assistance if deemed necessary. I understand that all associated costs incurred as a result of any action taken in this regard will be my responsibility.
